Tecmen Industry Day

While the uptick in COVID cases experienced during the summer of 2020 required a postponement of the 4th annual TeCMEN Industry Day from its standard August timeslot to April 14, 2021, the rescheduled event proved to be another strong success. In total, the event attracted nearly 300 attendees from throughout the Gulf Coast region and beyond. Attendees were treated to panels, presentations and workshops on timely topics ranging from the Federal Budget to Cybersecurity Maturity Model Certification (CMMC) regulations. The event's ever popular Technical Showcase / Expo Hall featured 40 leading companies, with many offering live technology and product demonstrations.

Nearly 200 public and private sector leaders came together on September 29, 2021 for a very timely breakfast presentation from Ms. Adrienne Slack, Regional Executive, US Federal Bank of Atlanta, New Orleans Branch. Slack's presentation, entitled "The U.S. Economy: Where Do We Go From Here?" touched on all manner of important

topics, ranging from the Federal Open Market Committee's current stance on interest rate hikes to the global supply chain. The event was sponsored by United Fidelity Bank.

Startup Okaloosa - Small Business Spotlights

Noting the uptick in new business starts during the COVID-19 pandemic, One Okaloosa launched Startup Okaloosa in 2020 as an on-line resource for individuals interested in starting and growing new businesses. Destin Fishing Fleet Business Seminars



In an effort to assist one of Okaloosa's oldest and proudest business segments, One Okaloosa EDC partnered with the Destin Area Chamber of Commerce and the Destin Charter Boat Association to offer a free "Business Best Practices Seminar Series" to local charter boat captains. Held at the Destin History & Fishing Museum and presented by select member companies of One Okaloosa and the Destin Chamber, individual topics included Business Plan Basics; Legal Structures; Protecting Your Livelihood & Mitigating Risk; Hiring, Firing & Employee Benefits; Financial Management & Record Keeping; and Banking for Business.

Professional Webinar Series

With individuals and businesses seeking good, actionable information and relevant professional growth opportunities close to home, One Okaloosa introduced a new Professional Webinar Series in 2021. These "no cost" learning opportunities include individual speakers or moderated panels, all accessible from wherever the attendee chooses to log-in. Webinar topics offered during 2021 included – "Building a Winning Career in a Technical Profession", "Using Branding & Technology to Reach Customers & Attract Talent" and "Creative Employee Retention in a Competitive Environment".

Talent Attraction Portal Enhancements

In an effort to assist local employers seeking to recruit personnel from outside the area, One Okaloosa's Relocation Portal is an on-line resource for individuals who may be exploring opportunities to relocate to Okaloosa County. Along with a jobs board, the portal features information on schools, healthcare, real estate and quality of life. Recognizing that newcomers often have need for new professional services provider relationships, a fully searchable Preferred Provider Directory was added in 2021.


TeCMEN Industry Day - School Ambassador Visits

Recognizing that today's students are tomorrow's employees and business owners, the opportunity for Okaloosa's bright young minds to be exposed to our area's vibrant defense, technology and manufacturing sectors at a professional business conference is obvious. Thanks to a partnership with the HSU Educational Foundation, some 25 students and teachers from the Okaloosa County School District and Rocky Bayou Christian School attended the 4th Annual TeCMEN Industry Day (TID) in April. The students – designated as "School Ambassadors" – sat in on presentations and enjoyed networking with TID attendees.

Over the past two years, the One Okaloosa team and select partners conducted

targeted face-to-face interviews with more than 40 local businesses operating within the aerospace, defense, engineering, manufacturing, and technology sectors. Identified as the Business Expansion Support Team (or BEST), the effort resulted in a clear and comprehensive understanding of the immediate and longer-term workforce needs these valued employers have. In an effort to connect companies seeking talent recruitment assistance with potential local solutions, One Okaloosa hosted a BEST Capstone breakfast event in August.

STRENGTHENING THE MILITARY MISSION

Recognizing the significant economic contributions generated by Okaloosa's military installations, One Okaloosa regularly monitors opportunities and

challenges faced by Eglin AFB and Hurlburt Field unit commanders. Utilizing volunteer liaisons, the Defense Support Initiatives committee engages in ongoing dialog with military commanders. A DSI Legislative Position paper is developed based on these inputs. Top priorities for 2021 included protecting the Military Mission Line and oil drilling moratorium, Eglin Gulf Test & Training Range buffering and infrastructure improvements, and community infrastructure.







STRENGTHENING THE MILITARY MISSION

Washington DC Congressional Outreach

Utilizing the DSI construct, One Okaloosa EDC executed a coordinated targeted outreach strategy in order to support, sustain and enhance Okaloosa's installations and missions. DSI leadership conducted virtual briefings with key Congressional offices and distributed the informative position paper identifying top priorities. This informational outreach resulted in critical provisions for Team Eglin within the 2022 National Defense Authorization Act, thus bolstering our National Defense.

Tri-County Community Partnership Initiative

Stood up in 2014, the TCPI provides a venue to incubate partnership opportunities between the military and civilian communities. In 2021, the TCPI Advisory Board created the Purple Star Schools Task Force in order to champion a statewide recognition program for K-12 schools who go above and beyond to support military families. In addition to providing inputs to the successful Purple Star Campuses of Distinction legislation co-sponsored by Rep. Patt Maney, the Task Force designed and distributed a promotional post card spotlighting the new recognition opportunity.





2021 SUCCESS SPOTLIGHT

It has been said before that economic development is a "team sport". This was never more evident than with "Project Dunk" – a One Okaloosa EDC industry recruitment project announced in October 2021.

Project Dunk – later revealed to be Purple Square Management – is a Tampabased management company with over 205 franchise locations in nine states, including 95 Dunkin' / Baskin Robbins stores throughout Florida and Alabama. The company will be constructing a 24,500 SF state-of-the-art commercial bakery and distribution facility on a four acre parcel located within the Okaloosa Industrial Air Park – county-owned property that was previously certified as "shovel-ready" through Gulf Power's Florida First Sites program. The company's real estate holding company closed on the purchase of the property with the Okaloosa County Board of County Commissioners on October 28, 2021. All told, the project will result in a \$4.5 million capital investment and the creation of 60 new jobs.

Key factors cited in Purple Square Management's decision were Okaloosa County's favorable geographic location, workforce characteristics and overall site readiness. Bottom line, from the company's perspective, Okaloosa County was ready when it mattered. In addition, partners including the Okaloosa County Board of County Commissioners, CareerSource Okaloosa Walton, Okaloosa Gas District and FPL all went the extra mile to assist One Okaloosa EDC in winning the project for our community.


